- Day of show entries will be accepted.

## **Directions to the Building:**

Address: 5167 Brownsville Rd., Pittsburgh, PA 15236

**From Downtown Pittsburgh:** Take the Liberty Bridge and go through the Liberty Tunnel, staying in the right lane. Turn right AFTER the light at the end of the tunnel onto the cloverleaf for Rt. 51 South. Turn right onto Streets Run Rd. Go to the T-intersection and turn left at the light onto Brownsville Rd. KCTC is on the left, just past Option Supply.

**From I-79:** Take I-79 to Exit 55. Turn right at the light at the end of the exit ramp onto Rt. 50 and get into the left lane. Turn left at the first light onto Vanadium Rd. Turn left at first light onto Bower Hill Rd. Turn right at the first light onto Kelso Rd. Go to the dead end and turn left at the T- intersection onto Painters Run Rd. It will change name to Conner Rd. Take it to the end at Rt. 88 (Library Rd.). Turn right onto Rt. 88, then turn left onto Broughton Rd. (Walgreens on the right corner). Go to the T- intersection and turn left at the light. Then go under the bridge and turn left onto Brownsville Rd. KCTC will be on the right just past the Loose Moose Saloon, and just before Option Supply.

**From the East:** Take the Parkway East (I-376) to the Boulevard of the Allies to the Liberty Bridge and go through the Liberty Tunnel, staying in the right lane. Turn right AFTER the light at the end of the tunnel onto the cloverleaf for Rt. 51 South. Turn right onto Streets Run Rd. Go to the T- intersection and turn left at the light onto Brownsville Rd. KCTC is on the left, just past Option Supply.

**Alternate Directions from the Far East to Avoid Downtown Pittsburgh Traffic:** Take I-70 West to Route 51 North. Go 18 miles. Take the 2<sup>nd</sup> cloverleaf exit at the top of a long hill (just past the U-Haul rental on the right) onto Curry Hollow Road west-bound (follow the Yellow Belt/Bethel Park/South Park sign). Go past the Sunoco station on the right, then down a long hill, and turn right onto Brownsville Road just before the overhead railroad bridge. KCTC will be approx. 0.8 miles on the right, just past the Loose Moose Saloon and just before Option Supply.

**From the South Hills or Finleyville or Library:** Take South Park Road or Route 88 North to the 5-way intersection (GetGo on the far corner). Take a right onto South Park Road (if coming from Route 88). (Note: South Park Road becomes Baptist Road.) Take the 2<sup>nd</sup> right onto Broughton Rd. Go to the T-intersection and turn left at the light. Then go under the railroad bridge and turn left at the light onto Brownsville Rd. KCTC will be approx.. 0.8 miles on the right, just past the Loose Moose Saloon and just before Option Supply.

**From South Park:** Take Brownsville Rd. Go under a railroad bridge, then turn left at the first light, staying on Brownsville Rd. KCTC will be approx. 0.8 miles on the right, just past the Loose Moose Saloon and just before Option Supply.

**From Elizabeth or Pleasant Hills:** Take Route 51 North. Exit at the cloverleaf just past the U-Haul dealer and follow the signs that say Yellow Belt/South Park/Bethel Park. Turn right only Lebanon Church Road. Go past the Sunoco station on the right, then down a long hill, and turn right onto Brownsville Road just before the overhead railroad bridge. KCTC will be approx.. 0.8 miles on the right, just past the Loose Moose Saloon and just before Option Supply.

**Using GPS?** Punch in **5167 Brownsville Rd., Pittsburgh, PA 15236**.

**Using Google Maps?** Punch in the street address, not “Keystone Canine Training Club”.  
Directions using the club name are incorrect.

## **Trial Schedule**

**Saturday:** beginning at 9 am

1. Level 1 - Scent Patrol (CW-SP) - Rounds 1 and 2
2. Level 4 - Scent Super Sleuth (CW-SSS) - Rounds 1 and 2

**Sunday:** beginning at 9 am

3. Level 2 - Scent Detective (CW-SD) - Rounds 1 and 2
4. Level 3 - Scent Investigator (CW-SI) - Rounds 1 and 2

**Resets:** Handlers may not repeat the same search with more than one dog. Therefore, we will be offering one reset per class for handlers who wish to work two dogs.

**Classes:** Teams may enter multiple Levels / Classes at the same trial. For those teams who are new to C-WAGS, this means that you may trial at Levels 1 and 2 at this trial. For additional information, please refer to the C-WAGS rules.

**Awards:** Qualifying ribbons will be awarded to Scent Detective teams who qualify. There are no placements.

Four (4) legs, under two (2) judges, are necessary to earn a new title.

New Title ribbons will be awarded to teams who complete their title, as well as ACE rosettes.

Other prizes / raffles will be available.

## **C-WAGS Notice to Exhibitors**

Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS Scent rules and regulations including but not limited to the following rules regarding entry:

- ◆ All exhibitors are expected to treat the judges, trial hosts, your canine teammate(s) and all other exhibitors with respect.
- ◆ All judges and trial hosts are expected to show respect to all exhibitors and their canine teammates.
- ◆ This trial is open to all dogs registered with C-WAGS.
- ◆ Trial Hosts may elect to accept FOR EXHIBITION ONLY (FEO) entries of non-registered dogs.
- ◆ Teams may be entered in multiple levels/classes at the same trial.
- ◆ Dogs must be shown by a member of the owner's immediate family.
- ◆ Collars: The dog must wear a flat type collar (buckle, snap or proper fit martingale) and/or body harness in the ring. Electronic training collars or prong collars are not allowed on the show grounds.
- ◆ Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- ◆ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.

### **In addition,**

- ◆ The organizing committee may refuse any entry for any reason.
- ◆ THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal.
- ◆ There will be no refunds if the trial has to be cancelled for any reason.
- ◆ Refunds will be made for females in season upon written request accompanied by a statement from the exhibitor's veterinarian.



- ◆ Returned checks do not constitute a valid entry. There will be a \$30.00 service charge for returned checks. Payment of entry fees and service charges shall be made by money order within 7 days of notice to exhibitor of returned check. Any fees not received within 7 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible.
- ◆ Dogs must be on leash while on show grounds unless being shown.
- ◆ Crating space is limited, so please be considerate of other competitors. **It is expressly understood that competitors alone are responsible for the behavior of their dogs.** Dogs must remain under control at all times while on trial grounds. Reactive or aggressive dogs' crates should be covered and must be monitored by their owners. Please restrict your practice or warm-ups to the designated areas, not the aisles between crates. Keystone Canine Club reserves the right to rearrange the crating to eliminate unsafe or disruptive behavior. Day kenneling only is permitted.
- ◆ All competitors through entry at this event waive any and all rights relative to video broadcast of this event.
- ◆ Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
- ◆ Please pick up after your dog(s).
