## KCTC MEMBERSHIP MEETING FEBRUARY 19, 2010 HIGHLIGHTS

BYLAW REVISION - The membership voted unanimously to approve the Bylaw revision previously circulated.

FINANCIAL AUDIT - A financial audit of the KCTC records has been completed. There were no problems, discrepancies or errors.

SNOW EMERGENCY PROCEDURE The consensus of those present was that the procedure we recently adopted for notifying people of class cancellations (phone recording and post on website) worked well.

WEBSITE - Pete Jr. described some new website features (Rainbow Bridge for deceased pets, Rally page, Building Usage page, and Class photos). Additional features (Obedience page, Dog Titles page, and Guestbook) are planned. He also stated that we now have a Facebook page.

BUILDING SEARCH - To better coordinate our search for a larger building, Dan volunteered to be the Board Liaison to Marcie Parrish for the building search. To help Marcie, Dan will send Marcie a list of "Must-Have" items and a list of "Wish-List" items,
based upon Board and membership input.

Pete \& Yvette Grandillo Jr. are very proud to announce that... Cammi, Dawson, and Bryce competed at the Puli Club of America agility trial in Zanesville, Ohio over the first weekend in March. It was a new facility that none of the dogs had ever competed on. Furthermore, this was only Bryce's second agility trial, and yet another new surface, equipment, sights, sounds, etc. Bryce overcame the new environment with a 1st place finish in Nov B Jumpers and a $1^{\text {st }}$ place finish in Nov B Standard. These qualifying runs earned him both his Novice Jumpers Title and his Novice Standard Title. Cammi responded by earning four qualifying $1^{\text {st }}$ place finishes in Exc B P Jumpers and Exc A P Standard. Dawson couldn't let anyone do any better than him. Dawson competing in Exc B Jww / Standard qualified in all four runs with a $4^{\text {th }}$ in Standard and a $3^{\text {rd }}$ in Jumpers (out of 38 entries). For the entire family, 10
qualifying runs out of 12 earned the kids another McDonalds. The two-hour trip home, not a peep was to be heard, only rapid paw movement from their dreams, and an occasional whimper in their doggie dreams.

For the entire weekend, Molly had 9 runs ( 5 in standard and 4 in games). Of the 9 runs, Molly qualified in 6 runs. In Games on Saturday, Molly qualified and earned two $2^{\text {nd }}$ Place finishes, one in CopyCat and one in Bowling. This also earned Molly her Games TG1 title. Also on Saturday, Molly had three standard runs in Beginner's Agility. Molly earned two $1^{\text {st }}$ place finishes and one $2^{\text {nd }}$ place finish resulting in her Beginner's Agility Title. In Games on Sunday, Molly moved-up into TG2 or Intermediate Games and continued her success with Chutes \& Ladders and Football. In both, Molly qualified with $1^{\text {st }}$ place finishes. ## TDI CANDIDATES WANTED

Have you ever considered your dog as one of those special damp nosed furry friends who through snuggles and puppy kisses could bring some love and kindness into someone's life? Ms Sarah Wiggle Butt and I have been welcomed in all kinds of settings around Pittsburgh; assisting elementary students to feel more comfortable with the written word through the Reading With Rover program, visiting long term nursing homes to help ease Alzheimer and hospice patients through difficult times, playing "fetch" with Veterans who are trying to reacclimate to the civilian world with counseling and job search.
When I first started my journey into the area of pet therapy, I had some doubts. Not about Ms Sarah (I knew she had plenty of puppy kisses to give away) but about my being able to interact with the clients and make a difference in quality of life. It seems that wherever I go and somebody finds out that I have a Therapy Dog, they want us to come and visit. Having a dog along often is the means to easily begin a conversation. The two ladies outside the VA Hospital who saw Ms Sarah and asked that I stop by and see their Dad in the hospice wing that was not expected to last the night. The wheelchair bound lady veteran psychiatric ward whose conversation during the week was the question of when Sarah would be back to visit.

Being retired, I do have a lot more time on my hands but none-the-less, it is still limited. There are seventeen assisted living facilities in the Bethel Park area and I don't know a single one of them that wouldn't like to have a four-legged volunteer. Please consider getting your dog-qualified CGC/TDI and becoming part of the program by sharing your dog with others who really appreciate your efforts.

## THERAPY DOG READING PROGRAM



What could be more helpful and comforting than reading to a dog? That is another wonderful program in which my therapy dogs, Heidi and Colby, participate. This program has been proven to be of great help to many shy children, beginning readers, or children with speech impediments. Many children just have great fear of speaking or reading in front of a group of their peers. This is where the dog becomes the best non-judgmental listener for these children.

The reading program can last from one to two hours. Therapy dogs must be calm and able to sit or lie down for 15 or 20 -minute sessions at a time. There could be eight different children reading to one dog in the two-hour period. Stress can become a problem in this length of time for some dogs, but what dog would not like all of the attention and petting that they get from the children. It is a win--win situation to all involved. An immediate bond is formed with the dog and reader, which is comforting to both. This is a one-on-one program when the stories are read to the

interested dog, but the dog will sometimes get so comfortable hearing
the story that it will fall asleep. Any anxiety of reading out loud that the child may have is easily and quickly removed by the gentle petting he gives to the dog as he continues to read. The child reads with no interruptions, corrections or help, unless he asks the dog's handler for assistance with a word.

Depending on the facility, whether a library or a classroom setting, the structure of the program may vary. Some readers like to visit and read to multiple dogs and others prefer to read to the same dog at each session. A close relationship builds and is made evident when the smiling little faces enter the room and joy and excitement is expressed as they seek out their favorite reading partner. The dogs respond very enthusiastically with their wagging tails when they see their friend approach them. The dogs remember their reading buddy each week and there is a very mutual and happy greeting.

It was five years ago when I researched this program and was totally impressed when I read a story about a child who was very, very shy at reading out loud. His first reading-to-the-dog session was a bit of a struggle, but he looked forward to returning the next time to the same dog. His teacher noticed a very remarkable improvement in this child's reading skills after the completion of this program. The boy had received a photo of his reading dog and put it on the refrigerator where he would sit and read to the picture. This is just another example of therapy dogs helping people, just by doing what they do best and what comes naturally.

So, if you like to read and love children, get your therapy dog and get involved. You will be glad that you did.

## LOW STRESS VET VISITS



Gain Credibility with your vet by using solid handling skills. Use a no-pull harness or head collar if necessary.

Teach your dog helpful behaviors such as how to lay flat on her side, accept restraint, and have her body handled.

Take frequent non-medical field trips to the vet hospital; call ahead, but stop in and feed your dog high-value treats outside the office and in the waiting room, and ask the staff to offer treats, too.

If you are not comfortable with this particular veterinarian, consider switching to another practice.
