That completed Sawyer's 17th title to date. We are ecstatic. Then today, he qualified in excellent jww at the Beaver Co. Agility trial to give him his 4th leg towards his Master's title. Sawyer has succeeded beyond my wildest imagination. What a guy.

Solomon aka CH Kelvington's Once 'N A Blue Moon also qualified at the same trials to finish his HT title. He needs a few more titles and he will also have his CH VCX title. He is getting ready to show in rally and will soon have those final points too!

As always, both dogs were breeder, owner handled. We are so proud of both of our boys. We floated home from the trial.

Peter & Yvette Grandillo are very proud to announce that... in the first weekend of September, Cammi, Dawson, and Bryce competed at the Westmoreland County Obedience Club Agility Trial. Cammi qualified in 5 of the 6 runs in Exc B P 12". In all five runs, Cammi came in 1st. Dawson qualified in all six runs in Exc B 20". Dawson earned 3 double-Q's, two 3rd place finishes, one 4th place finish and 113 MACH points. Bryce qualified in five of six runs in Exc B 16". Bryce earned 2 double-Q's, two 1st place finishes, one 2nd place finish, two 3rd place finishes, and 182 MACH points.

Most importantly, at this trial, Dawson earned his MACH 5. We couldn't be more proud of Dawson's accomplishments.

Also, Cammi, Dawson, and Bryce competed at the Beaver County Kennel Club agility trial in mid-September. Cammi earned three 1st place finishes in Jww Exc B P 12". Dawson qualified in all six runs in Exc B 20" earning three double-Q's and 110 MACH points. Bryce qualified in five of the six runs in Exc B 16". Bryce earned two 1st place finishes, two 2nd place

finishes, one 3rd place finish and 177 MACH points.

Most importantly, at this trail Bryce qualified for the AKC National Agility Championships. At the beginning of the year, our goal for Bryce, as a pup, was to just get into Exc B by the end of the year. Not only did he get past Novice, Open, Exc A and into Exc B, he double-Q'd six times in Exc B with over 512 MACH points. Bryce was able to accomplish his Novice, Open, and Exc A titles in six weekends of showing and in three weekends of showing in Exc B, Bryce qualified for the AKC Nationals Agility Championships.

What a fun and exhausting weekend we had at the TDAA trial in Washingtonville on September 18 and 19! It was my first time to run both of my dogs in an agility trial, as well as Pixie's first time to run Beginner Standard and Pebbles' first time to run Superior Standard.

Pebbles earned two Qs in Games II, with one 1st-place and one 2nd-place finish, and one Q in Games III and her TG2 title! Dog Idioms

Ever wonder what your favorite dog-related expressions really mean? Or where they come from? Here's a list of the most

commonly used dog idioms, their meanings, and possible origins.

Bark up the wrong tree – Pursue an erroneous course of action. *Origin:* In the 19th century when hunting raccoons, one had to go out at night (and typically brought a dog to help). The pursued raccoon would likely flee up a tree and the dog was called to wait at the base and bark until the hunter arrived. If the dog had the wrong tree, the hunter was unlikely to get his prey. Davy Crockett used the expression in his 1833 text, "Sketches and Eccentricities."

A barking dog never bites- Someone who makes threats all the time seldom carries out the threats. *Origin:* The proverb is recorded from the 16th century in English, but the idea is found in Latin in the works of the Roman historian Quintus Curtius.

Better be the head of a dog than the tail of a lion. -It is better to be the leader of a less prestigious group than to be a subordinate in a more prestigious one.

Big dog –Important person *** **Top dog** -
The most important and powerful person in a group

Bird dog –An unexpected tackle or approach from behind; Someone who is interested in romancing another's partner. *Origin:* retrievers and pointers that assist hunters locate their prey when they have shot a bird, or pounce on them to retrieve it; the phrase was immortalized by the Everly Brothers in their 1950's song of the same name
