### Chicken Salad Croissants (The cooking artist is Lisa Sbei)

- · 2 12.5 oz. cans of chunk chicken breast in water
- 1 small onion, chopped
- 2 stalks of celery, chopped
- Dried cranberries
- Sliced almonds
